

In 2021, Heritage Building Restoration Grants were awarded to the owners of Maximilian's Restaurant, the Butcher's Edge building and the owner of the RBC building. The Grant is available to the owner(s) of heritage designated properties (industrial, commercial, or residential) who have completed an approved restoration of a heritage feature. In 2021, the Town issued 25 Heritage Permits, bringing the grand total to 246 permits issued since 2012.
